NOTICE

The new water list has a column of who will water at night. Day light time is 5:00AM to 7:30PM this time of year. If you cannot water at night pass to the next in line who can water. It is important to keep the water moving at all times so we may expect to receive water within a 2 week period or sooner. Communicate

The person watering at night, needs to finish and can pass it to the next person in the morning when they have completed.

If you cannot water when it is your turn, please swap with your neighbors. This Is permitted, however, don't pass on the water and then try to pick it up a few days later when it has moved on past your area. There have been people who assume no one is watering at night and take the water and that has caused a lot of frustration to the people who are trying to keep the water moving. The bottom line is PLEASE BE CONSIDERATE AND DON'T TAKE THE WATER OUT OF TURN.

It is also important for each of us to cross off our name after we have watered. This lets people be able to go to the list at the box and see where the water is. If your neighbors have watered and they have not crossed off, please cross their names off as you are crossing off yours. We would like to try to keep this up to date so people don't have to call around and drive around wondering who has the water.
